1. Parties to the Contract

The Grantor: Anthony (known as “Anton”) Moglia, author and creator of the fonts, operating under the status of an artist-author within the individual company Anthony Moglia, based at 22 Montée Milou, 13013 Marseille, registered under the SIRET number 83305010700014.

The Licensee (hereinafter referred to as “you”): The individual or legal entity that purchases the license and to whom usage rights are granted, as identified on the purchase invoice.

2. Definitions

“Font” or “Fonts” refers to the complete typographic work, including: the original design of glyphs, and all technical elements contained in digital files (vector glyphs, metrics, spacing, kerning data, hinting, rendering instructions, metadata), as well as all bitmap and/or vector representations of characters generated by or derived from font files, regardless of their format or method of creation.

“Workstation”: Computer/tablet where the font is installed

“Authorized Users”: Employees, permanent collaborators, and regular freelancers of the licensee, within the limits of the subscribed quota.

3. Entire Agreement

This licensing contract, along with your purchase invoice, constitutes the complete agreement governing the use of the acquired fonts. No prior conditions, other documents (quotations, email exchanges, third-party general terms), or verbal agreements can modify, supplement, or cancel the terms of this license.

4. Granted Usage Rights

This license grants you the non-exclusive right to reproduce and display the Font in your personal and commercial projects (printed materials, digital content, online communication), within the limits of the chosen formula, as specified and reminded on your purchase invoice.

Provided formats: OTF (desktop use), WOFF/WOFF2 (web integration), and Variable Font when available.

You can install the fonts on your web servers provided that they prevent any direct access and downloading of the files by third parties. Prefer Web Font formats (WOFF/WOFF2) with appropriate CSS protections.

Any use not expressly authorized by this license is prohibited.

5. Usage Restrictions

5.a. It is prohibited to resell, rent, or redistribute the fonts.

The resale, rental, gifting, or distribution of the fonts are strictly prohibited. It is also forbidden to store the fonts in publicly accessible directories, including unprotected CDNs, public Git repositories, or public Figma projects.

Warning : Agencies and freelancers who share fonts with clients without the appropriate license assume liability. Only static final creations (vectorized logos, visuals, PDFs) can be sent to clients without them needing a license in their name.

5.b. No modifications are allowed.

Modifying, distorting, converting, or renaming the fonts is strictly prohibited. Only the Grantor is authorized to make changes to the font files.

5.c. Distribution on unsecured web servers

Installing font files on any server accessible publicly via the Internet is strictly prohibited. This includes unprotected CDNs, public Git repositories (GitHub, GitLab...), and any hosting that allows direct file downloads.

5.d. Letterform-Based Products or Services

It is prohibited to create products or services whose main selling point would be based on the letterforms of the fonts (alphabetic merchandise, derivative products, text generators). You must obtain a dedicated license before using the fonts in a commercial product where individual letters are sold or accessible, or that allows unauthorized users to create custom designs with the font.

5.e. Political and Religious Uses or Uses Contrary to Public Order and Decency

The use of the fonts for political or religious communication, direct or indirect, is prohibited without prior written authorization from the Grantor. This restriction aims to preserve the neutrality of typographic creations. Any use contrary to public order and decency is strictly prohibited.

5.f. NFT & Blockchain

The use of the fonts for NFT creations or other blockchain applications is prohibited without prior written agreement from the Grantor.

5.g. Artificial Intelligence and Machine Learning

It is strictly prohibited to use the fonts for training artificial intelligence models (AI/ML), uploading files on generation services (such as ChatGPT or Midjourney, for example), analyzing shapes with learning algorithms (Machine Learning), or generating derivative fonts via artificial intelligence.

5.h. Usage Restrictions Exceptions

Exception for Logotypes

Within the context of a logo only, you may make minor vector adjustments for visual balance (spacing, alignment) directly within

the final logo file, with the Grantor's approval. Modifications should only concern the exported final logo file, not the font files themselves. This authorization does not extend to creating new fonts or other uses.

Temporary Transmission to Service Providers

You may transmit the font files to your technical service providers (printers, developers) for project realization, provided that they delete them within 30 days following the end of their assignment.

6. Financial Conditions

In consideration for the present license, the Licensee shall pay the Grantor the amount set forth on the purchase invoice and in accordance with the payment terms specified therein.

7. After-Sales Service

7.a. Technical Support

Free technical support is provided within 30 days of your purchase for assistance with font file installation, resolving system compatibility issues, and fixing proven technical malfunctions.

Support is provided by email to support@moglia.fr.

This warranty covers only technical aspects, not creative assistance or customization requests.

7.b. Refund Policy : No refunds are possible after purchase validation and font file delivery. You are encouraged to thoroughly test the fonts before finalizing your order.

7.c. License Transfer in Case of Merger/Acquisition

In case of merger, acquisition or business transfer, the license can be transferred free of charge to the acquirer once, subject to written notification and verification that the new entity complies with the limits of the original license. The Grantor may object for just cause. If the acquiring entity exceeds the authorized quotas, an additional cost will be applied to adapt the license.

8. General Legal Provisions

8.a. Contract Modifications

This contract can only be modified by a written agreement signed by both parties. It reserves the right to change the terms of this license for new purchases, but existing licenses remain governed by their original conditions.

8.b. Termination for Non-Compliance

In case of violation of these license terms, the license will be immediately terminated by sending written notice to the other party without financial compensation. The user must then destroy all font files and their copies within a period of seven days and provide written confirmation of this destruction upon request by Anton Moglia.

8.c. Duration and territory

This license applies worldwide, with no geographical restrictions, except for specific territorial exclusivity clauses that may have been negotiated. The right of use is granted for the duration of copyright: you retain the right to use the version of the fonts acquired as long as you comply with this license's conditions and within the authorized quotas.

8.d. Intellectual property and liability limitations

Anton Moglia guarantees that he is the original author of the fonts and that they do not infringe any third-party intellectual property rights.

The fonts are provided "as is," without any express or implied warranties beyond the guarantee of originality.

In no event shall the Grantor be liable for any indirect, incidental, special or consequential damages resulting from the use or inability to use the fonts, even if the Grantor has been informed of the possibility of such damages. The user assumes full responsibility for the use of the fonts and the compliance of this use with applicable law. In any case, the Grantor's liability, whatever its cause or nature, shall not exceed the amount actually paid by the Licensee for this license.

Anton Moglia is not responsible for damages caused by misuse of his fonts by the end user or third parties.

The granted rights are non-exclusive, meaning that other users may acquire the same rights. They are also non-assignable and non-transferable: you cannot transfer this license to a third party, and it remains personal, linked to your entity, except in cases of merger or company acquisition (see article 7.c.). Finally, these rights are limited to the quotas defined according to the chosen license option.

Anton Moglia remains the exclusive owner of the character fonts and all their components (glyphs, metrics, kerning data, hinting, etc.).

The fonts remain the exclusive intellectual property of Anton Moglia at all times, including after integration into your creations. You may never claim ownership rights to the fonts themselves. You only acquire a usage right under the conditions defined in this license.

8.e. Language of the contract

This contract is available in French and English. In case of interpretation discrepancies between the two versions, the French version prevails and is authoritative.

8.f. Governing law and jurisdiction

This agreement as a whole is governed by French law. In case of dispute, after an attempt at amicable resolution, only the French courts shall have jurisdiction, and more specifically those of the jurisdiction of the grantor's headquarters.
